

#### **Terms and Conditions:**

- Accelerated programs should be completed within 60 days from the date of enrollment.
- Accelerated programs should be paid in full.
- Accelerated program fees are non-refundable.
- After 60 days, all remaining packaged hours are considered forfeit and students revert to regular pay as you go structure.
- Within 60 days, if the hours exceed package hours, all additional hours are paid at the published hourly rates.
